General Information:-

- Admission to the West Bengal State Quota/Private Management Quota/NRI Quota PG Medical/Dental seats 2020 in the affiliated Institutions of the West Bengal University of Health Sciences (WBUHS) in different Post Graduate Medical/Dental Courses (MD/MS Degree,PG Diploma and MDS) shall be made on the basis of the inter se merit lists of "Status" [Unreserved; Economically Weaker Section (EWS); Other Backward Class (OBC including OBC A and OBC B); Scheduled Caste (SC); Scheduled Tribe (ST) and Person with disability (PwD) Jamong open category, in service category and other service category of candidates appearing and qualifying in the NEET PG 2020/ NEET MDS 2020 Examination conducted by National Board of Examinations (NBE) and fulfilling the eligibility criteria for appearing in the online counselling for West Bengal State Quota/Private Management Quota/NRI Quota PG Medical/Dental seats 2020 respectively. The weightage of marks incentive or reservation in aforesaid categories for in-service candidates will be considered as per Post Graduate Medical Education Regulation of Medical Council of India and latest orders of Government of West Bengal in this regard such as HFW-23099/29/2019/373 dated 26.02.2020 for Post Graduate Medical courses; HFW-23099/29/2019/27 dated 26.02.2020 for Post Graduate Dental courses and Deptt. Memorandum No HF/O/MERT/296/HFW-23099/29/2019 dated 04.03.2020 for Post Graduate Medical Degree and Diploma courses.
- 2. In order to be eligible for admission to any post graduate course in 2020 admission session, it shall be necessary for an unreserved or EWS candidate to obtain minimum marks at 50th percentile in NEET PG 2020/NEET MDS 2020 as provided by NBE. However in respect of candidates belonging to Scheduled Caste,

Scheduled Tribe and Other Backward Classes, the minimum marks shall be at $40^{\rm th}$ percentile. For benchmark PwD candidates, the minimum marks shall be at $45^{\rm th}$ percentile for UR/EWS and $40^{\rm th}$ percentile for SC/ST/OBC-A/OBC-B candidates.

- In reservation of seats for SC/ST/OBC A/OBC B candidates, policy expressed in 3. The West Bengal State Higher Educational Institutions (Reservation in Admission) Act 2013 will be followed except for the Central Government Institutes. However only where the new seats are added in the State Govt. run Medical/Dental colleges after the date of publication of this act, share of those seats will go in favour of OBC candidates leaving aside share of SC and ST candidates as long as the share of seats for OBC candidates will not reach 10% for OBC A and 7% for OBC B. Otherwise OBC category non creamy layer candidates will have to exercise option in counselling as unreserved category. In All India Institute of Hygiene and Public Health (AIIH & PH Kolkata), ESI-PGIMSR and ESIC Hospital, Maniktala and ESI-PGIMSR and ESIC Hospital, Joka in allotment of reserved category SC/ST/OBC seats, Govt. of India reservation policy will be followed. OBC category candidates including OBC-A and OBC - B have to submit non-creamy layer income certificate issued on or after 01.04.2019 by the Certificate Issuing Authority.
- 4. The caste certificate issued/validated in the State of West Bengal will only be considered for allotment of reserved category SC/ST/OBC-A/OBC-B seats of State quota except for the Central Government Institutes. In All India Institute of Hygiene and Public Health (AIIH & PH Kolkata), ESI-PGIMSR and ESIC Hospital, Maniktala and ESI-PGIMSR and ESIC Hospital, Joka in allotment of reserved category SC/ST/OBC seats of state quota caste certificate issued from other states will also be considered.
- 5. Five percent seats of the annual sanctioned intake capacity shall be filled up by benchmark PwD (person with disability) candidates before they are included in the sanctioned seats for respective UR/EWS/SC/ST/OBCA/OBCB candidates.

- 6. The benchmark PWD certificate must be issued from Medical Board of IPGME&R Kolkata. Such PwD candidates must have obtained at least 45th percentile marks in UR/EWS category and at least 40th percentile marks in SC/ST/OBCA/OBCB category in NEET PG 2020/NEET MDS 2020 examination for being considered for PwD category. This is as per MCI gazette notification dated 4th February 2019 bearing memo no MCI-34(41)/2018-Med./170045 in accordance with the provisions of the Rights of Persons with Disability Act 2016.
- 7. The candidates who did their Medical/Dental Graduation from foreign countries must have permanent registration with State Medical Council/Medical Council of India/State Dental Council/Dental Council of India. They have to submit necessary document regarding Nationality and other criteria enforced by Medical/Dental Council of India for eligibility.
- 8. Tenure of training period is two complete years for PG Diploma and three complete years for PG Degree from the date of joining in the course. Therefore the candidate will consider his/her eligibility before filling up forms considering these aspects.
- 9. As per provision of PG Regulation of Medical Council of India, 2000 amended up to May 2018, PG Degree/ Diploma course will start from 2 May,2020 (1st May being holiday). The date of start of course in MDS will be similar. Date of start of training period will be verified from date of start of stipend for Open Category candidates and date of actual placement on Trainee Reserve for in-service doctors (i.e. the date of drawl of salary as Trainee Reserve) from the college authorities concerned.
- 10. Admission to the Post-Graduate Medical/Dental Degree/ Diploma Courses will not be allowed unless the candidates have got themselves registered either with the West Bengal Medical/Dental Council or with the Medical/Dental Council of India. Candidates registered with other State Medical/Dental Councils will have to be registered with WBMC/MCI/WBDC/DCI (as applicable) before admission.

- Discontinuation of course at any time after admission before completion of 11. course tenure will attract penalty of Rs 5 lakhs for PG Degree Medical/Dental seats PG vide G.O. No. Rs 2 lakhs for Diploma seats or. HF/O/MERT/1542/Admn./ME/STM-28-10 dated 25th October 2010. completion of the course, the open category candidate has to serve bond period of Govt. of West Bengal else have to pay penalty as fixed by Govt of West Bengal. The State Govt. Order HF/O/MERT/923/ME-MISC-78-13 dated 10.06.2014 in respect of rendering service after completion of course is applicable for Open category admitting candidates.
- 12. The choice regarding Category (open category or in service category or other service category) once exercised cannot be subsequently changed. The option exercised by the candidate regarding Caste and Person with Disability (PwD) status during the NEET PG 2020/NEET MDS 2020 application will be verified and if found appropriate as per State rule, will be considered during choice filling and seat allotment of reserved category seats. Therefore, applicant will have to be very particular and cautious during filling up of form. There is no scope for correction of mistake made by a candidate later.
- 13. Eligibility criteria for West Bengal State quota seats (in Govt and Private Medical/Dental Colleges in West Bengal affiliated under WBUHS) in PG Medical/Dental 2020:-

(i) Open Category candidates:-

a. State Government vide its Memo no HF/O/MERT/570/2H-06/14 dated 01.12.2014 and subsequent vide no. HF/O/MERT/1588/2H-06/14 dated 04.12.2014 and in pursuance of order of Hon'ble Calcutta High Court vide W P no 32902 of 2015 dated 15.1.2015 defined the eligibility criteria for applying as "Open Category candidates" for State Quota seats. Those candidates who are enrolled in the NEET PG 2020/NEET MDS 2020 application as either have passed MBBS/BDS from the State of West Bengal respectively or have stated that permanent residence State is West

Bengal will **only** be considered as **Open category candidates for State quota** seats provided the relevant documents of the respective candidates are found to be appropriate during physical verification (See Annexure-I for further instructions).

b. Any Open category Candidate who has been already pursuing PG Degree or PG Diploma or any other course in any Institution/ college under any University is not eligible for taking part in counselling unless the course training period ends latest by 30.04.2020 and s/he is free from all encumbrances from execution of indemnity bond by 30.04.2020. The Open Category Candidate after completion of PG Degree or Diploma course must render service in this state for a period as decided by the Dept of Health and Family Welfare, Govt of WB.

(ii) In Service Category candidates:-

a. The candidates under regular service for 3 years or more (date of eligibility before31.03.2020) under the 'Department of Health and Family Welfare', Govt. of West Bengal in--West Bengal Health Service(WBHS) or West Bengal Medical Education Service(WBMES) or West Bengal Public Health and Administrative Service(WBPH&AS) and eligible vide "The West Bengal Medical Education Service and the West Bengal Health Service and the West Bengal Public Health-cum-Administrative Service (Placement on Trainee Reserve) Rules 2015" Gazetted vide memo no. HF/O/MERT/508/ME/TR-07-2012 published on 2nd Iune 2015 [Henceforth will be called TR Rules 2015] and Memo HF/O/MA/136/HPT/32M-122-2015 Dt. 21.01.2016 with subsequent amendments vide Memo No. HF/O/MA/215/4P-01/17/PT-I dated 6th March 2018 and Memo No. HF/O/MA/216/4P-01/17/PT-I dated 6th March 2018, and HF/O/MA/326/4P-01/17/Pt-H/HFW-25009 dated 28th February,2019 will only be considered as in-service category candidates for NEET PG 2020 counselling provided they must also have completed at least

three years of rural service under Dept of Health and Family Welfare Govt. of West Bengal as regular service period by the last date of 31.03.2020 or must be otherwise eligible vide relevant TR orders to apply for the training reserve from Dept of Health and Family Welfare, Govt. of West Bengal.

- b. Similarly the candidates under regular service for 3 years or more (date of eligibility on or before 31.03.2020) under the Department of Health and Family Welfare Govt. of West Bengal in West Bengal Dental Service (WBDS) or West Bengal Dental Education Service (WBDES) and eligible vide latest T.R rules [The West Bengal Dental Education Service and the West Bengal Dental Service](Placement on Trainee Reserve) Rules 2013" (hence forth called as TR Rules 2013) published vide memo no. HF/O/DENTAL/232/ME/TR-02-2012 dated Kolkata the 24th September 2013] in respect of WBDS and WBDES of Department of Health and F.W will only be considered as in-service category candidates for NEET MDS 2020 counselling.
- c. These candidates who opt for in-service category are not allowed to convert to open category/other service category and vice versa.
- d. The candidates who have been in Regular Service with the Health and Family Welfare Department, (WBMES/ WBHS/ WBPH&AS/WBDS/WBDES) of Government of West Bengal and eligible and permitted vide latest T.R Rules for taking part in counselling and for availing Training Reserve are only eligible to apply as service category candidates. Placement on trainee reserve/release otherwise for studying is strictly based on latest T.R rules and subsequent relevant orders issued by 'Health and Family Welfare Department', Government of West Bengal, see Annexure-II for further instructions. The total number of allotment in Trainee Reserve (WBMES/

WBHS/ WBPH&AS/WBDS/ WBDES) will be as per available TR posts for 2020 based on caste and inter se merit of in service candidates in NEET PG 2020 or NEET MDS 2020 examination as per direction of Health and Family Welfare Department', Government of West Bengal. If there is a tie with TR post being less than the eligible candidates, higher the duration of regular service would be considered earlier for TR post. If still tied, then higher the chronological age of the candidate would be considered earlier for TR post. Mere enrolment for participation in Counselling for West Bengal PG Medical/Dental State Quota & Private Management Quota seats 2020 and registration, exercise of choice and allotment of seat in counselling does not confirm placement in training reserve, which is at the discretion of the 'Dept of Health and F.W', Govt of West Bengal.

- e. Eligibility of in-service candidate pursuing or possession of PG Diploma/ Fellowship in any discipline and placed on Trainee Reserve at any time during service career is also subject to prevalent Rulesand Orders in force of the Health and Family Welfare Department, Government of West Bengal. The TR Rules 2015 with latest amendment will be applicable. Relevant orders and Rules of Government of West Bengal issued from time to time will be followed for eligibility and other associated issues.
- f. The Date of Birth of the Candidate opting for in-service category candidates must be on or after 31.3.1970. It is reiterated that candidate is not eligible if he/she is more than 50 years of age on 31.3.2020 as per provision of regulation of rule 3 sub rule (IV) of The TR Rules 2015 with latest amendment.
- g. In case of In-service category, PG Degree holder is not allowed for further PG course but PG Diploma/Fellowship holder may opt for PG Degree course if

required period of service rendered is in consonance with the provision of The TR Rules 2015 with latest amendment. Service candidates who did his/her diploma/fellowship through getting placement on Trainee Reserve are allowed to apply provided the TR period for pursuing PG Diploma/Fellowship Course was completed by 30.04.2018. It is reiterated that in-service doctor with PG Diploma will not be eligible for joining another PG Diploma and in-service doctors with PG Degree will not be eligible for another PG Degree/Diploma even if he/she acquired such Degree / Diploma before/after joining the service. The State Government reserves the absolute right to allow/disallow placement on Trainee Reserve for in-service category candidates.

Note 1:-

As per notifications of the Dept. Of Health and Family Welfare, Govt. of West Bengal such as HFW-23099/29/2019/373 dated 26.02.2020 for Post Graduate Medical courses; HFW-23099/29/2019/27 dated 26.02.2020 for Post Graduate Dental courses and Deptt. Memorandum No HF/O/MERT/296/HFW-23099/29/2019 dated 04.03.2020 for Post Graduate Medical Degree and Diploma courses in pursuance to the PG Medical Education Regulation of Medical Council of India and similar regulation of Dental Council of India, there will be no seat reservation for the in-service candidates in PG Degree seats.

The West Bengal Medical Counselling Committee, Dept of Health and Family Welfare, Govt of West Bengal, would prepare a combined merit list of **Open candidates**, **in-service candidates** of Dept of Health and Family Welfare, Govt of West Bengal and **other service candidates** based on the marks incentive provided for in service candidates only, as per provision of such notifications cited above. In case of tie due to the provision of such marks incentive, the higher original NEET PG 2020/NEET MDS 2020 rank will be

placed at higher position. Such obtained combined list will be renamed as **State Serial Number for the particular Round.**

It may be mentioned here that individual candidate can enrol only once before either Round 1 or Round 2 or Centralized Manual Mop Up Round of the Counselling. The opportunity for enrolment for a candidate who had not enrolled earlier would re-open before Round 2 or Centralized Mop Up Round. In such scenario, it may so happen that State Serial Number may change for that particular round and hence before commencement of each round a list of eligible candidates bearing the State Serial Number for that particular Round would be published.

Thus State Serial Number is a dynamic number for that particular round and allotment in that round would be based on the State Serial Number for that Round only.

Candidate/s who fails to get enrolled in earlier round must remember that when he/she enrols in a particular round later on followed by verification, registration and choice filling, the allotment can be made only from the available vacancies for that round only.

from the employer to pursue the course. Otherwise such application will not be entertained. Availability of stipend to all such admitted candidates will depend upon the decision of the employer and the admitting institute.

14. Eligibility criteria for Private Management quota seats in PG Medical/Dental 2020:-

The **Management Quota** in the Private Institutions in West Bengal in 2020 are also going to be filled up by online counselling which is to be conducted by West Bengal Medical Counselling Committee (WBMCC) of Dept of Health and Family Welfare, Govt. of West Bengal through the same online portal used for conducting counselling for WB State Quota PG Medical/Dental seats 2020.

The Indian National candidates qualified in NEET PG 2020/NEET MDS 2020, irrespective of MBBS/BDS passing State and Permanent Residence State, are eligible to participate for allotment in Private Management Quota seats in West Bengal.

There is no caste reservation (EWS/SC/ST/OBC/OBC A/OBC B) in Private Management Quota seats, so reserved caste candidates have to appear as Unreserved. The eligibility criteria to be considered for allotment of such seats are the cut off for Unreserved in NEET PG 2020/NEET MDS 2020 (as applicable).

Candidates who are eligible to participate in the West Bengal state quota seats 2020 are also eligible to participate in Private Management Quota seat allotment, if they obtained the cut off marks for UR candidates in NEET PG/NEET MDS 2020 as well as if they wish so.

Any candidate who is citizen of India and having permanent residence in the State of West Bengal or outside the State of West Bengal who is qualified

through NEET PG 2020/NEET MDS 2020 (examination being conducted by NBE authorities) can apply for the management quota of the Private Medical/Dental College in West Bengal (as applicable). For that matter, the above mentioned Open category, In-service category and other service category candidates are also eligible to apply for the management quota of the Private Medical/Dental College (as applicable).

The names of the Private colleges are as follows:- KPC Medical College Jadavpur, IQ City Medical College Durgapur, ICARE Medical College Haldia, Guru Nanak Institute of Dental Science and Research Panihati, Haldia Institute of Dental Science and Research Haldia.

In the Private management quota seats of West Bengal 2020, the seat allotment will be done entirely based on inter se merit rank of the candidates from the Combined list (based on the State Serial Number for that particular Round) of the eligible and qualified candidates after providing marks incentives to in service candidates of Dept of Health and Family Welfare, Govt of West Bengal without otherwise consideration of any category, caste or quota (Candidates are advised to refer to Note 1).

The fee structure of such seats will be informed to the candidate in the counselling website. Candidates are hereby directed to contact the colleges for detailed clarification of such fees and mode of payment before putting up choices for such seats during the choice filling period of counselling.

This is absolutely essential because if the candidate is allotted to such seat, he/she has to get himself/herself admitted in that seat in that round after completing all necessary formalities for such admission else the candidature will be cancelled due to non reporting and the candidate cannot participate in subsequent round/s of counselling.

15. Eligibility criteria for NRI quota seats in PG Medical/Dental 2020:-

The NRI quota in the Private institutions in West Bengal in 2020 are also going to be filled up by online counselling which is to be conducted by West Bengal Medical Counselling Committee (WBMCC) of Dept of Health and Family Welfare, Govt. of West Bengal through the same online portal used for conducting counselling for WB State Quota PG Medical/Dental seats 2020. The candidates who are qualified in NEET PG 2020/NEET MDS 2020 and fulfil the criterion of eligibility of NRI quota seats as per the directions/orders of the Hon'ble Supreme Court of India in the case WP Civil 689 of 2017 [Consortium of Deemed Universities in Karnataka (CODEUNIK) and Anr. Vs the Union of India and Ors. Dated 22.08.2017 and principles set in Anshul Tomar (supra) case in West Bengal and other relevant orders are only be considered in NRI Quota seats. There is no caste reservation in NRI Quota seats.

During enrolment, an eligible and qualified candidate will be asked to state whether he/she belongs to NRI (Non Resident Indian) / OCI (Overseas Citizen of India) or PIO (People of Indian origin). If the candidate states in affirmative then he/she can proceed further for enrolment as NRI/OCI/PIO candidate and would be eligible for choice filling and consideration for allotment in NRI quota seats after document verification.

Such candidate cannot participate for State Quota or Private Management Quota seats. Similarly candidates, who are otherwise eligible for State Quota and Or Private College Management Quota seats, are not allowed for choice filling in NRI Quota seats for obvious reasons.
