Notice for modified tentative schedule WB NEET PG/NEET MDS 2020 counseling

In view of the extension of the last date of admission in Round 2 All India Quota counseling till 30th June 2020, the earlier published schedule for round 2 WB PG 2020 counseling needs to be modified. Communications has been received regarding delayed update of online payment for counseling from Newly enrolled candidates in round 2. It has also been observed that some verification is still pending owing to the delayed receipt of some documents from candidates during the verification period in round 2. Court Case order is also received regarding marks incentives of in service candidates. It is also required to omit the names of candidates who are remaining admitted after round 2 of All India Quota counseling in view of Supreme Court order. Such procedure is to be undertaken on 3rd July 2020. The online surrender facility shall be in place till 4 P.M of 3rd July 2020 for candidates who are admitted in WB PG counseling but not satisfied with the seat. Such surrender shall be without penalty. The names of such surrender candidates shall also be removed from the eligible list. After all such procedure the final list of eligible candidates for round 2 shall be published on 6th July 2020.

The seat matrix for round 2 shall include non allotted seat of WB PG counseling in round 1; non reported seats WB PG counseling in round 1; surrendered or cancelled seats of WB PG counseling in round 1; returned vacant All India Quota seats to WB PG State Quota. The returned vacant All India Quota seats shall be re-rostered as per state rule with provision of 10% seats for EWS candidates. The modified tentative schedule is as follows:-
