**Notice regarding revision of seat matrix and corrigendum of earlier notice dated  
07-02-2022 bearing memo no. HFW-23099/92/2021/M/170.**

Tentative seat matrix for WB NEET UG 2021 counseling was published on 3<sup>rd</sup> February 2022 providing reservation as per existing Rules.

In view of representations received from the candidates participating in WB NEET UG 2021 counseling and after careful consideration it has been decided to revise the seat matrix by adjustment of seats of EWS/OBCA/OBCB in State Quota seats of such colleges in WB where no seat was increased since last academic session. In such colleges seat categorization like that of previous year i.e. WB NEET UG 2020 counseling is followed, being non-contentious.

The colleges where the seats are increased since last academic session or when new college/s are added, the State's reservation policy as aforesaid is followed.

In view of the revision of seat matrix, it is felt that fresh registration and choice filling shall be allowed from **6 pm of 9<sup>th</sup> February 2022 till 7 am of 11<sup>th</sup> February 2022.**

The locked choices of candidates who have already filled up choice and saved them, is unlocked in order to enable them to modify choice as per their wish following the revised seat matrix. Such candidates may not fill or modify choice if they don't want. They may simply lock the choices again or system shall auto-lock such last saved choices after choice filing period gets over as per server time. Such candidates shall bear in mind that due to seat adjustment in revised seat matrix, some of their choices may become defunct and shall not be processed during seat allotment for obvious reasons. Seat allotment will be done by following the revised seat matrix only and any prior seat choice if exercised by candidate before publication of revised seat matrix will not be available for allotment.

The revised date of publication of list of candidates who have successfully registered and filled up choice for Round 1 of WB NEET UG counseling 2021 is **11<sup>th</sup> February 2022 after 4 pm.**

The revised date for publication of result of allotment for Round 1 of WB NEET UG counseling 2021 is **14<sup>th</sup> February 2022 after 4 pm.**

The revised dates of admission in allotted colleges are from **15<sup>th</sup> February 2022 till 17<sup>th</sup> February 2022** (all 3 days from 10 am till 4 pm as per server time).

The NRI candidates who get allotment have to attend prior physical verification at Swasthya Bhavan on **15<sup>th</sup> or 16<sup>th</sup> February 2022 between 11 am till 5 pm** as per server time. Only after successful verification they can move for admission in respective allotted college.

The terms such as "NEET PG" or "NEET PG 2021" in earlier notice dated 7<sup>th</sup> February 2022 shall be read as "NEET UG" and "NEET UG 2021".

The revised dates for round 2 of WB NEET UG 2021 counseling shall be notified later on. The rest portion of the notice dated 7<sup>th</sup> February 2022 remains as it is.
