Notice and schedule WB UG 2021 mop up counseling

The eligibility for WB UG 2021 mop up, stray round and college round counseling shall be as per earlier notice no. HFW-23099/40/2022/M/153 dated 01.02.2022 published in counseling website and also as per further updates/corrigendum/addendum in the said website www.wbmcc.nic.in

The cut off for UG Ayush is reduced by AACCC authority (5 percentile across all categories) vide notice L-14030/12/2022-EP-1 dated 30.03.2022 for Ayush UG seats only. Such candidates are advised not to fill choice for UG Medical and Dental for obvious reasons. Even if they do so, their choices shall not be processed for allotment.

The ineligible candidate list is published by AACCC vide notice L-14030/12/2022-EP-1 dated 29.03.2022 for not allowing to participate in UG seats in WB UG 2021 counseling as they are presently admitted in round 1 and round 2 of AACCC UG counseling 2021.

In view of possible conversion of seats as stated in notice HFW-23099/40/2022/M/153 dated 01.02.2022, such choices shall be available for candidates as virtual choices (virtual vacancy) in the choice table for choice filling if they want so. Such choices shall only be processed for allotment if such conversion actually takes place.

The candidates who get provisional allotment at newly allotted college, have to report physically for original document verification with requisite fees within schedule time for admission and must obtain server generated admission letter from the newly allotted college upon successful verification.
