## Notice for Special Stray Vacancy round WB PG Medical / Dental 2022

In view of notice of DGHS, Nirman Bhavan, New Delhi dated 03.01.2023 bearing reference no. U-12021/01/2022-MEC, and as plenty of PG Medical seats (MD/MS/Diploma /DNB Degree, DNB Diploma) and few MDS seats are remaining vacant, hence in larger interest of candidates, the competent authority has decided to conduct a special stray vacancy round WB PG Medical / Dental 2022, so that the precious seats do not go waste.

No fresh registration will take place in special stray vacancy round. However, the already registered and eligible candidates who have not paid fee or have not verified themselves earlier, shall be given another chance to do so for this round as per schedule published in counseling website <a href="https://www.wbmcc.nic.in">www.wbmcc.nic.in</a>.

Publication of eligible candidate list shall not only exclude already admitted candidates through AIQ or SQ counseling as per list published in <a href="www.mcc.nic.in">www.mcc.nic.in</a> website, but also shall exclude the allotted candidates in AIQ Stray and Special Stray Vacancy Round 2022.

The eligible and already registered candidates who are not holding any seat either in AIQ or State Quota are hereby allowed to participate in this special stray vacancy round. They have to furnish an undertaking that they are not holding any seat in previous rounds of NEET PG Counseling 2022 conducted by All India Counseling Authority or any State Quota Counseling Authority. They must further state that, they agree to participate in Special Stray Vacancy Round of NEET PG 2022 counseling and they understand that these remaining vacant seats are precious in nature. If they are allotted a seat during the special stray vacancy round, they will get admitted and join the seat after paying due college fee, submission of required college documents / bond or bank guaranty (as applicable). They shall also have to undertake that if they fail to do so their details shall be sent to competent authority to debar them from taking NEET PG 2023 Examination. Also any action including legal action may be taken by the competent authority against such candidate.

There shall be allotment cum admission on 14-01-2023 at the respective college as per schedule published in website <a href="www.wbmcc.nic.in">www.wbmcc.nic.in</a>. However, Private Medical and Dental Colleges (Gouri Devi Institute of Medical Sciences And Hospital, ICARE Institute of Medical Science and Research, IQ City Medical College Hospital, JIMS Budge Budge, KPC Medical College and Hospital Jadavpur, Guru Nanak Institute of Dental Sciences and Research, Haldia Institute of Dental Sciences & Research) allotment cum admission kiosk shall be set within the premises of RG Kar Medical College Kolkata like previous Stray Round.

On that particular day of allotment cum admission, the eligible candidate personally has to attend any one college as per his/her sweet wish with original documents as required, one set self attested photocopy of such documents and the requisite fee and bond / bank guarantee (as applicable) arranged beforehand. The candidate has to contact respective college authority for mode of payment and bond / bank guarantee beforehand.

The allotment and admission letter shall have to be generated by the college authority from NIC server and one copy shall be handed over to the concerned candidate after due authentication.

The concerned college authorities have to fill up the admitted candidates details by 14.01.2023 within the time frame in NMC or DCI website positively.
