Subject: Continuation of Recognition of MBBS degree (150 seats) granted by West Bengal University of Health Sciences, Kolkata in respect of the students being trained at IQ-City Medical College, Burdwan, West Bengal.

Sir,

I am directed to refer to your application for grant of Continuation of Recognition of MBBS degree (150 seats) awarded by West Bengal University of Health Sciences, Kolkata in respect of the students being trained at IQ-City Medical College, Burdwan, West Bengal and to say that your college was assessed by the Assessors appointed by MARB to conduct physical verification of the facilities, hospital OPD, bed occupancy etc. on 15th March, 2023. The report of virtual assessment is not available with UGMEB. However, as per the decision taken in the Commission in its meeting held on 11.04.2023, in case infrastructural assessment as well as examination assessment have been carried out, the application for Continuation of Recognition should be processed as per the regulation norms. In case only one assessment has been carried out, Continuation of Recognition is to be processed **for only one year** henceforth.

2. Accordingly, your application for grant of Continuation of Recognition (for one year only) of MBBS degree 150 seats, awarded by West Bengal University of Health Sciences, Kolkata in respect of the students being trained at IQ-City Medical College, Burdwan, West Bengal has been considered in Under Graduate Medical Education Board (UGMEB). While evaluating the physical assessment report alongwith the AEBAS and HMIS data including CCTV, certain deficiencies were noted and the same were communicated to the college authorities vide UGMEB's letter dated 16.05.2023 for compliance.

3. In response to the above, the Principal, IQ-City Medical College, Burdwan, West Bengal vide letter dated 23.05.2023 submitted their reply with regard to the deficiencies pointed out by UGMEB in its letter dated 16.05.2023. Subsequently, an opportunity of the personal hearing was also given to the college authorities on 30.05.2023.

4. After hearing the college authorities and careful consideration of the facts and compliance, it has been decided by the Under Graduate Medical Education Board (UGMEB) that IQ-City Medical College, Burdwan, West Bengal is granted **one year** recognition to the MBBS qualification in respect of the students admitted in the year 2018-19. However, they shall apply afresh for Continuation of Recognition in 2024.

5. Accordingly, the approval of the competent authority in UGMEB is hereby conveyed for grant of **CONTINUATION OF RECOGNITION FOR ONE YEAR** for MBBS degree for 150 students, granted by West Bengal University of Health Sciences, Kolkata in respect of the students being trained at IQ-City Medical College, Burdwan, West Bengal.
6. However, the college authorities are advised to apply afresh to UGMEB in 2024 for Continuation of Recognition, at least six (6) months prior to the final examination of MBBS Part-II (Practical) alongwith the requisite fee i.e. of Rs.3.54 lakhs only.
7. This issues with the approval of President, UGMEB.
