### Ragging includes any or all of the following

- Violation of decency
- Criminal intimidation/wrongful restraint
- Undermining human dignity
- Financial exploitation/extortion
- Use of criminal force

### A student indulging in ragging can be

- Expelled from the institution
- Banned from the mess/hostel
- His/her scholarships can be withdrawn
- Debarred from giving examinations
- Debarred from admission to any institution
- Criminally prosecuted
